Dear Ms. Johansson

Upon suggestion from the director of the botanical garden in Uppsala we have moved our small botanical garden from Vienna/Austria to Ven/Sweden in 2017.

Since 1,5 year nothing is done by the previous owner to remove mixture of manure and plastic. See **goetsel_ensilage.jpg** The fact of the mixture of manure and plastic was not known by us at the time of the purchase (nobody mixes silage with manure).

The ground is partially contaminated with the silage plastic left by the previous owner. The goat manure is consistently mixed (like lasagne) with the thin silage plastic which is slowly disintegrating into the micro plastic. <http://www.ecolanum.com/index.html#cont>

We have isolated the area as you can see **cont_area1.jpg**

We have already had visit on Ven USA experts and we have developed the method to remove the plastic. It is a very complex process. It is clear that something has to be done soon. We get a good support from the Landskrona municipality but the time is pressing (micro plastic ♦ we don♦t use the area, not to disturb the contaminated area - it is like a graveyard)

We are worried that nothing is happening. We are marketing internationally our ecology ♦garden-in-creation♦, we have many visitors, and we will get more from England next year where we have registered ourselves as an open garden - the current state is embarrassing.
