subject: heavy pollution and overexploitation of the natural environment on the island of Ven.

Dear all,

Since we move to Ven in 2017 we are receiving request for opinion about the construction intended to be erected in our vicinity "grannehörande".

We try to answer according to some principles which we could refer to as "ecology" and including historic components such as contamination of the environment. Our mark, 32:3 and 25:12 which were one unit before, are **contaminated with the micro plastic** spread around from abandoned silage plastic wrap.

We are puzzled as the island of Ven is "sold" as an example of beauty and a fruitful coexistence of the nature and agriculture. Nothing can be more wrong. **The life of the Island is heavily influenced by over-fertilization, use of herbicides resulting in biological "death" of natural water resources**, the flora exposed to Roe Deer (rådjur) is greatly reduced when comparing to the list of plants described by Arvid Nilsson in his book "Hven, Vegetation och Flora". **There are very few amphibians** and especially the presence of the European green toad, (Den grönfläckiga paddan, Bufo viridis, [Grönfläckig padda - Världsnaturfonden WWF](#)) is threatened.

We have created fantastic ponds on our property, unfortunately like everywhere else the water is virtually "dead" the string algae dominate in spring then they die making the water unliveable. The nice looking "dam" vid Möllebäcken is empty of

aquatic life, virtually nothing lives in the water. **There are very few insects on Ven and almost no insects which larvae feed in the water like a dragon fly.**

There are very few wild or “natural” habitats of the island, all is agriculture or houses. **The animals such as roe deer, hares and pheasants are fed the year round. The Island is a one big farm.** Animals, especially roe deer suffer from malnutrition as many nutritious components are missing due to very limited variety of plants which were depleted (i skiljevall) by the same animals i.e. the large population roe deer

We are planning to apply for funds from the EU for the ecological restoration and development of rewilding concept for our property as a part of the wider view of the ecology of Ven, but

We are providing the two substantial considerations, warnings and possibly obstacles. Both points below have to be reviewed and answer found before any other activity proceeds.

1. The area of Tuna 25:12 Jöns Möllars Väg 8 and 10 (and our property 32:3) are contaminated with the micro plastic in the form disintegrated ensilage plastic, any work in the area will resurface the plastic which will flow to the sea.
2. The legal status of property 25:12 is questionable. The property was purchased from Lucas Björne son of the owner Glenn Björne who was the owner of our property too. Glenn Björne has executed the donation as a way to escape legal and financial responsibility for both 25:12 and our property 32:3 and the liabilities since at least 2015. The micro plastic is still not removed from our property
